### Technical

2. All items should pass CB and IECEE, if can not pass CB and IECEE, Seller should take all the responsibility which cause by this.
3. For order, Seller can not change any material which will affect the quality without Buyer's confirmation. If change, buyer will not pick up the goods and seller must return the full amount.
4. All goods specifications should completely match the specifications agreed on and mentioned in quotation and priced according to, if change, buyer will not pick up the goods and seller must return the full amount which already paid.
5. Product Dimensions should completely match the dimensions agreed on by both seller and buyer and mentioned in quotation.
6. Stable power and light efficiency both should less than 5% tolerance.
7. Screws must be matched with face ring screw holes and be tightened. All items come with pair of suitable screws.
8. The quality is based on the confirmed sample, if any change, seller should inform the buyer and get the buyer's confirmation in advance .
9. Material: Brushed Rose Gold Iron, with clean inner surface.

4. Product can not have any seller's information or inspect mark or Chinese.

5. Color box designed by buyer and printed by seller.

6. Light label and user manual and color box designed by buyer and must be printed by seller ,light label must be put on light, user manual and warranty card put in box by seller.

#### **Warranty & Inspection**

1. Product inspection: when Buyer inspect the goods by count/weight/try to assemble/visual appearance/Test by machine and so on. If find any part not meet the contract requirement or have quality problem, seller have to return full amount deposit.

2. Warranty time 5 years, if any defective happen during the warranty period, seller will replace it free of charge.

3. Have quality problem, Seller have to return full amount which buyer already paid.
