





1. FOB PRICE.

Technical

1. Stable power and light efficiency both should less than 5% tolerance
2. Seller must make sure the goods matched with buyer's standard, the quality will base on contract and sealed sample.
3. All items should pass CB and IECEE, if can not pass CB and IECEE, Seller should take all the responsibility which cause by this.
4. All goods specifications should completely match the specifications agreed on and mentioned in quotation and priced according to ,if change, buyer will not pick up the goods and seller must return the full amount which already paid.
5. For order, Seller can not change any material which will affect the quality without Buyer's confirmation. If change, buyer will not pick up the goods and seller must return the full amount.
6. The quality is based on the confirmed sample, if any change, seller should inform the buyer and get the buyer's confirmation in advance .
7. Material: Sandy Black Metal with Acrylic Diffuser.
8. Product Dimensions should completely match the dimensions agreed on by both seller and buyer and mentioned in quotation.
9. Color temperature 3000K, LED by Samsung (SMD 2835), Powered by Eaglerise. If any change in led and driver brand buyer will not pick up the goods and seller must return the full amount which already paid.
10. Light body color should be as agreed on buy buyer and seller and with best quality without any spots or scratches which is Sandy black, any change in body color and color quality buyer will not pick up the goods and seller must return the full amount which already paid.
11. Screws must be matched with face ring screw holes and be tightened. All items come with pair of suitable screws.
12. The light color of the finished product is uniform, without dark areas, black spots and white spots. No light-leaking.
13. All electrical accessories and terminals in use must be RAFEED sourced from OJUN.

Delivery & Payment

1. Deposit 20% in advance, 80% balance will be paid before delivery.
2. Seller will start the production once the order is confirmed, deposit can be paid within two weeks from contract confirmed.

Production & Packaging

1. Package and all part of product need keep clean, if not must rework.
2. The seller shall provide the packing of the goods in accordance with the requirements of moisture-proof, shockproof and unbreakable, and maintain the quality of the materials.
3. Package requirement: Buyer standard.
