### Technical

1. PCB can't print seller's logo or item number
2. Seller must make sure the goods matched with Buyer standard, the quality will base on contract and sealed sample.
3. For repeat order, Seller can not change any material without Buyer's confirmation. If the compents are updated, the seller will provide samples to the buyer for comfirmation before production, if no, buyer will not pick up the goods and seller must return the full amount which already paid.
4. All items should pass CB and IECEE, if can not pass CB and IECEE, Seller should take all the responsibility which cause by this. Buyer will pay the cost for CB and IECEE.
5. Max output power tolerance less than 5%.
