2. All accessories and fixing screws made of stainless steel
3. Total height :2000mm
4. Body color: Black, as seller standard black color.
5. Must be able to have 2\*T8 , 2\*16W Tube double ended
6. Light device must have all required specifications to obtain ingress protection value of IP65
7. Color of the head part and pole must be the same
8. Seller must make sure the goods matched with buyer's standard, the quality will be based on contract
9. Housing material: aluminum, the surface shall be smooth and level, no cracks, no holes, no scratches, no dust, no raised particles, uniform spray paint
