Technical

1. Seller must make sure the goods matched with Buyer standard, the quality will base on contract and sealed sample.
2. Used Material: Covestro(Bayer) Polycarbonates material, Color: white and black.
3. Seller should got buyer's confirmation if need to change any specs or used material , if change the buyer will have the right to not take delivery of the good and seller need to return whole payment for the corresponding order.
4. seller must laser print buyer code at the backside of the items.

Delivery & Payment

1. Delivery time:45days
2. Payment term: 20% deposit before production, 80% balance against BL.

Production & Packaging

1. Package and all part of product need keep clean, if not must rework.
2. Products can not have any seller's information or marks in Chinese.
3. Package and all part of product need keep clean, if not must rework.
4. each item should be packed with white transparent bag, bags should be packed with normal white box, boxes should be packed with normal brown carton.
5. package component shall not to be a recycled component for secondary use.

Warranty & Inspection

1. Product inspection: when Buyer inspect the goods by count/weight/try to assemble/visual appearance/Test by machine and so on. If find any part not meet the contract requirement or have quality problem, seller have to return full amount which already paid
2. Warranty: 10 year
3. After sale service policy: for the unartificial defective items, seller will replace the whole products base on the defective qty free of charge; if the defective qty reach 10%, buyer can return the whole order qty to Seller, and seller should return the order amount to buyer base on the return qty, and all the cost for return the goods will bear by seller; if seller need defective sample for test, buyer will send to China and seller will bear all the shipping cost.
