General

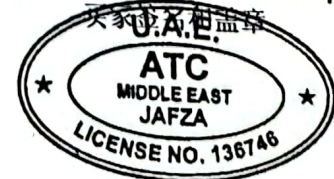
1. For Flood light: Mold fee 125,000RMB for open mold 10W 30W 50W 100W Fitting, 50% mold fee should pay as deposit, 40% mold fee should pay when mold been finished and sample confirmed; 10% should pay before load all the qty of first order. Buyer already paid 90% mold fee.
2. For Flood light:For the mold fee will be return base on the percentage of order amount each time, when the order amount reach 850,000USD will return the whole mold fee.
3. For Flood light:The mold should open base on Buyer's design, weight different should within 10% (Subject to actual sample) ; the fitting can be work for reflector(beam angle 120°) or reflector(beam angle 90°); the fitting with spiracle; the hook should be 360°rotate.
4. For Flood light:PCB should add buy's logo
5. Transfer and confidentiality: the seller has no right to transfer this contract, the seller and buyer both sides must abide by the contract, shall not be foreign to expose the contract content, such as has occurred, a responsibility shall be investigated for the other party.
6. The goods of this contract products is seller produce according to the buyer's brand, the seller shall not be entitled to the finished product

Logistic

1. PORT OF LOADING : FOB Ningbo, for LCL shipment buyer will pick up the goods to Foshan, buyer will pay the logistics cost and seller will pay the local cost base on CBM if load the container in Guangdong province.

Technical

1. All items should pass CB and IECEE, if can not pass CB and IECEE, Seller should take all the responsibility which cause by this. And Seller will responsible for all the cost which should pay in China for make CB and IECEE, Buyer will responsible for all the cost which should pay in Saudi Arabia for make CB and IECEE and energy efficiency.(Base on each certification which we got.)
2. Wire: color,wire diameter,line length, ground line, line mark should can be pass CB certification
3. Material:Aluminium+transparent glass,Fitting Color:white,Outlux LED, Epistar Chip, SMD2835 1W/PCS,DOB Outlux Driver,Yageo Capacitor,10W PF:0.8,others PF:0.9,CRI/RA>70,AC176V-265V 50/60Hz,Beam angle:120°,IP65,working temperature:-40~+50°C,lifespan:50000h
4. Stable power and light efficiency both should less than 10% tolerance
5. Color temperature: White 6000K color temperature for each batch can not more than 500K ,Warm white 3000K color temperature for Each batch can not more than 300K , neutral light 4000K color temperature for Each batch can not more than 300K ,with last batch and same batch.
6. Seller must make sure the goods matched with Buyer standard, the quality will base on contract and sealed sample.
7. For repeat order, Seller can not change any material without Buyer's confirmation. If the components are updated, the seller will provide samples to the buyer for confirmation before production, if no, buyer will not pick up the goods and seller must return the full amount which already paid.

Delivery & Payment

1. Delivery time: After deposit received around in 40 days. The buyer must arrange shipment within 7 days of all goods ready
2. Deposit 20% in advance, 80% balance will be ship against documents. If Port of loading isn't Ningbo,Deposit 20% in advance, 80% balance payment before shipment.

Production & Packaging

1. Product can not have any seller's information or inspect mark or Chinese
2. Package requirement subject to first order packing.The design of the color box is the same as the previous order.

Warranty & Inspection

1. Guarantee 3 years, if any defective happened from product quality problem, seller will replace the whole light free of charge and bear the international shipping cost.
2. Product inspection:when Buyer inspect the goods by count/weight/try to assemble/visual appearance/Test by machine and so on. If find any part not meet the contract requirement or have quality problem,seller and buyer negotiated to resolve,if not resolved, seller have to return full amount which buyer paid.
