## terms & condition

### General

1. Mold fee 40,000USD for open three set of mold for 150W 200W 300W Flood light Fitting, 60% mold fee should pay as deposit, 40% mold fee should pay when mold been finished and flood light sample confirmed by first parties. The mold fee 40,000USD has already been paid on first order of contract No.:ATC-ZHL20190801.

2. For the mold fee will be return base on the percentage of order amount each time, when the order amount reach 1,200,000 USD will finish return all the mold fee



3. The mold should open base on the buyer's design, weight different should within 5% as buyer's samples; the fitting can be work for reflector (beam angle 120°) or lens (beam angle 90°); the fitting with spiracle; lens and PCB should put the buyer's logo; the hook should be 340° rotate.

4. Transfer and confidentiality: the seller has no right to transfer this contract, the seller and buyer both sides must abide by the contract, shall not be foreign to expose the contract content, such as has occurred, a responsibility shall be investigated for the other party.

5. The goods of this contract products is seller produce according to the buyer's brand, the seller shall not be entitled to the finished product sales to a third party without authorization.

**Logistic**

1. PORT OF LOADING : FCL FOB Shenzhen, for LCL shipment when amount more than 20,000USD seller will send the goods to the ATC company in Foshan, Guzhen and seller will pay the local cost base on CBM.

**Technical**

1. All items should pass CB and IECEE, if can not pass CB and IECEE, Seller should take all the responsibility which cause by this. And Seller will responsible for all the cost which should pay in China for make CB and IECEE, Buyer will responsible for all the cost which should pay in Saudi Arabia for make CB and IECEE.

2. KEDI LED, Focus/HC Chip, 1W/PCS, 5.8-6.4V/150MA, SMD2835, CRI>80, DOB driver, PF>0.9, 176-265V 50/60Hz

3. Material: Die-casting Aluminum ADC12+Glass Fitting in white color, screw cap should in pink color

4. IP65, Beam angle: 115°, Working Temperature: -20°C ~ +45°C, Lifespan: 30000Hrs

5. Stable power and light efficiency both should less than 10% tolerance

6. Color temperature: White 6500K, Warm white 3000K; Difference of color temperature for Each batch can not more than 300K with last batch and same batch.

7. Seller must make sure the goods matched with Buyer standard, the quality will base on contract and sealed sample.

8. For repeat order, Seller can not change any material without Buyer's confirmation. If the components are updated, the seller will provide samples to the buyer for confirmation before production, if no, buyer will not pick up the goods and seller must return the full amount which already paid.

**Delivery & Payment**

1. Delivery time: 50-60days after deposit and package received (Official holidays are not included)

2. Seller produce the order when confirm the contract, 100% balance will be paid against B/L

**Production & Packaging**

1. Product can not have any seller's information or inspect mark or Chinese

2. Package requirement based on design file.

3. Package and all part of product need keep clean, if not must rework.

**Warranty & Inspection**



1. Product inspection:when Buyer inspect the goods by count/weight/try to assemble/visual appearance/Test by machine and so on. If find any part not meet the contract requirement or have quality problem, seller have to return full amount which already paid.

2. Guarantee 3 years. The defective rate of each order less than 0.4%, buyer will bear the loss; if defective rate exceeding 0.4%, seller should return this order amount on next order base on defective qtys or reproduce the qty base on defective items; if the defective rate more than 8%, seller will send QC to buyer's warehouse to check and bear all the responsibility for return this order amount base on defective qtys or reproduce the qty base on defective items. Reach 15% defective percentage, buyer will stop sell and seller bear all the responsibility for return this order amount base on defective qtys or reproduce the qty base on defective items.
