#### General



- 1. All items should pass CB and IECEE, if can not pass CB and IECEE, Seller should take all the responsibility which cause by this. And Seller will responsible for all the cost which should pay in China for make CB and IECEE, Buyer will responsible for all the cost which should pay in Saudi Arabia for make CB and IECEE.

- 8. Should put waterproof connector between wires and strip light
- 9. Color temperature: color temperature is Warm white 3000K Difference of color temperature for Each batch can not be recognize by eyes with last batch and same batch
- 10. Use 3M tape
- 11. White color for PCB of strip
- 12. 5m/roll for SMD strip light
- 13. PCB back side with 3M tape.
- 14. Print buyer's logo on all strip lights PCB
- 15. 5m/roll

- 7. color box all need put 1 pcs warranty card in it and 1pcs Hologram label and user manual in it. Warranty card and Hologram label provide by buyer, each color box paste one pcs Hologram label, Watch out for Numbers on false labels. Don't put them upside down. The color box should be cutter the tooth for hologram label position
- 8. Electrostatic bag need print as buyer's design and paste buyer's product label
- 9. Strips should use the roll by buyer's mold,and sticker the colorful label on two side of reel according buyer's brand
- 10. Package requirement: Buyer standard
- 11. The PCB of strip light should includes the buyer's logo
- 12. Hologarm label: Hologarm label provide by buyer, each color box paste one pcs Hologarm label, Watch out for Numbers on false labels.
