### General

1. Transfer and confidentiality: The Seller has no right to transfer this contract, The Seller and The Buyer both sides must abide by the contract, shall not be foreign to expose the contract content, such as has occurred, a responsibility shall be investigated for the other party.
2. The goods of this contract products is The Seller produce according to the The Buyer's brand, The Seller shall not be entitled to the finished product sales to a third party without authorization.
3. All the finished products in this contract should produce in The Seller's factory, if produce in third parties, The Buyer can cancel the order and The Seller must return all the amount which paid by The Buyer. The Buyer will make inspection during production or after production.

### Logistic

1. Documentation: The seller must provide all relevant documentation before shipment, including warranties, certifications and compliance reports.
2. EXW, for the goods which will load in Zhongshan, Jiangmen, Foshan, goods can send to buyer's assign location.  
If seller need tax refund, seller should pay custom declaration cost.

### Technical

1. Power consumption and Light Efficiency less than 5% tolerance.
2. Color Temperature Consistency: The difference in color temperature between batches must not exceed 200K when compared to the last batch or within the same production batch; Difference of color temperature for Each batch can not be recognize by eyes.
3. Certification Requirements: All items should pass CB and IECEE and with CB certification, if can not pass CB or IECEE, the Seller should take all the responsibility which cause by this. And the Seller will responsible for all the cost which should pay in China for make CB and IECEE, the Buyer will responsible for all the cost which should pay in Saudi Arabia for make CB and IECEE.
4. Product Specifics: Compliance: Products must pass CB, SASO, CE, and RoHS certifications. Compatibility: Must support WiFi and Bluetooth dimming and be compatible with the Tuya platform. Branding: The seller must label the WiFi and Bluetooth device with the buyer's logo (RAFEED) and must not display any information related to the seller.

#### **Delivery & Payment**

1. Payment term: 20% deposit, 80% balance against document.

2. Delivery time: 25 days after confirming the order.

3. Packaging fees: 100\$ will pay temporary, when total orders reach 1000 pcs, the seller will refund the 100\$.

#### **Production & Packaging**

1. The Seller should make a sample base on product requirement from the contract for The Buyer's confirmation before production.

2. Customize Package requirement pls check from another file, Product can not have any supplier information or inspect mark or Chinese; Package and all part of product need keep clean, if not must rework.

3. Controller needs to use the buyer's LOGO

4. The products should be in a color box (2pcs), the color boxes should be in inner carton, the inner cartons should be in outer carton.

5. The Seller must make sure the goods matched with The Buyer's standard, the quality will base on contract and sealed sample.

6. For repeat order, The Seller can not change any material without The Buyer's confirmation. If change, The Buyer will not pick up the goods and The Seller must return the full amount which paid by the Buyer.

#### **Warranty & Inspection**

1. Warranty: 5 years is required for all products.

2. Product inspection: when Buyer inspect the goods by count/weight/try to assemble/visual appearance/Test by machine and so on. If find any part not meet the contract requirement or have quality problem, seller have to return full amount which the Buyer paid.

3. After sale service policy: If any defective problem happened, The Seller will provide same item finished products for replacement free of charge; if the defective rate more than 5%, The Buyer will stop sell this item in the market and The Seller will reproduce the whole order free of charge or return the whole amount which The Buyer paid for this order. If seller want to send back the goods to China, the seller will bear all the shipping cost and other cost and arrange the shipment.
