4. The Seller must make sure the goods matched with The Buyer's standard, the quality will base on contract and sealed sample.
5. All items should pass CB and IECEE, if can not pass CB and IECEE, Seller should take all the responsibility which cause by this. And Seller will responsible for all the cost which should pay in China for make CB and IECEE, Buyer will responsible for all the cost which should pay in Saudi Arabia for make CB and IECEE.
